

- Hands-on experience in every aspect of Zero Waste



COLORADO LAGS BEHIND IN RECYCLING

- 15% recycling rate is less than half the national average
- Largely open market, private hauler trash and recycling collection
- Few cities/towns manage recycling services
- Limited state-level waste policies compared to leading states and no bottle deposit program

BUILDING TOWARD POLICY SOLUTIONS



A PRODUCER RESPONSIBILITY SYSTEM FOR CONTAINERS, PACKAGING, AND PAPER WILL:



Increase our recycling rate and reduce climate pollution.



Provide free recycling for all Coloradans, including those living in apartments and in rural areas.



Develop a clear common list of what can be recycled statewide.



Save local governments money by reimbursing their costs to run recycling programs.



Support Colorado businesses by creating a more resilient domestic supply of raw materials to make new products.



Create financial incentives for companies to reduce unnecessary packaging and use greener, more recyclable materials.

WHAT CO EPR LAW WILL DO



Develop a convenient, cost-effective statewide recycling system with free recycling to all residents



Be funded and managed by producers who sell packaging and paper in and into the state



Set up industry-run program with appropriate government oversight and advisory board of key stakeholders

HOW EPR IN COLORADO WILL WORK

Companies selling packaging and paper join Producer Responsibility Organization (PRO)

Producers pay dues to the non-profit PRO or submit their own individual plan.

PRO develops plan to improve recycling statewide.

Advisory board reviews plan, state approves plan and enforces regulations

PRO contracts with service providers to provide convenient recycling at no charge to all residents.

KEY ELEMENTS OF CO EPR



\$ 100% industry funded & operated



SCOPE: Consumer facing packaging



SCOPE: Includes printed paper and food serviceware



SCOPE: Residents then expand to small business



GOALS: Set by needs assessment



IMPACT: Free recycling

ROLE OF LOCAL GOVERNMENTS

PRO contracts with private and public service providers


Utilize and expand on existing businesses

No requirement for local governments to be service providers

Reimbursement for 100% of net costs



PROGRAM OVERSIGHT



IMPLEMENTATION TIMELINE

2023

- State agency convenes Advisory Board
- Producer Responsibility Organization (PRO) forms
- PRO conducts needs assessment

2024

- Legislature approves recycling goals, estimated costs
- PRO drafts program plan

2025

- Advisory Board reviews plan, gives recommendations to state agency
- State agency solicits public feedback, approves plan

2026
