### Key Dates

- January: Confirmation Hearings and Votes (Secretary of Agriculture, EPA Administrator)
- January 20: Inauguration/First Day Executive Actions
- April 28: FY 2017 Continuing Resolution Expires
- September 30: Deadline for FY 2018 spending bills
- September 30, 2018: Farm Bill Expires


### The Trump Administration

- Energy/Environment Priorities:
  - Energy development: oil, gas, coal
  - Deregulation
  - Reversing Obama Administration climate policies
- But also:
  - Conserve "our wonderful natural resources and beautiful natural habitats"
  - Refocus EPA on "its core mission of ensuring clean air, and clean, safe drinking water for all Americans"
  - Respect for States

### Deregulation

"Any regulation that is outdated, unnecessary, bad for workers, or contrary to the national interest will be scrapped. We will also eliminate duplication, provide regulatory certainty, and trust local officials and local residents."



- End "War on Coal"/Climate Change
- Regulations (CRA)
- WOTUS
- REINS Act
- ESA/NEPA

### Congressional Review Act

- Enacted in 1996 and used once in 2001
- Time limits: Final rules submitted after 6/13/2016 likely subject to CRA
- No filibuster but takes Senate floor time
- Potential candidates include:

-Stream Protection Rule


-Dept. of Interior Gas Venting and Flaring Rule

## Appropriations

- FY 2017:
  - CR expires 4/28– CR through 9/30?
- FY 2018: Regular Order?
- TMDL Amendment to FY 2017 Interior Bill
  - House approved 231-197 on 7/13/16
  - No provision in Senate
  - Not included in CR

#### Farm Bill

- Expires 9/30/2018
- Identify priorities and draft proposals now
- Politico: "Discussions around the 2018 farm bill are expected to pick up in earnest after the presidential election."
