


# What is Sustainable, Responsible and Impact (SRI) Investing?


#### Sustainable Investment Market Growth

- Current practices in PA, MD and VA regarding SRI investing of public funds
- Current state laws pertaining to SRI investing
- Identify opportunities to incorporate SRI investing in state laws



## SRI Investing Opportunities in the Chesapeake Bay Region

- SRI Investing Legislation:
  - Add language to state code that enables or requires ESG consideration for state funds (ex: pension funds)
  - Create a sustainable investment option for state employees retirement savings plan



## SRI Investing Opportunities in the Chesapeake Bay Region

**Request State Treasurer:** 

- Vote proxies that are in alignment with state priorities
- Submit shareholder proposals that are in alignment with state priorities
- Request portfolio review that ensures investments are aligned with state priorities
