2:15 P.M. CHESAPEAKE BAY TMDL INDICATOR
In February, the Chesapeake Bay Program debuted a new indicator that demonstrates progress toward meeting the clean water goals of the Watershed Agreement. The Chesapeake Bay Watershed Total Maximum Daily Load indicator uses both monitored and

modeled data to estimate nitrogen and phosphorus pollution reductions in response to implemented best management practices. What does this new indicator reveal about gaps in planning, implementation, and response?
